The Guaynabo-Toa Baja Local Workforce Development Board (LWDB) is requesting proposals from qualified organizations (Educators, Universities, Community-Based Organizations, Non-profit or For-profit Organizations, Industry Trainers and Employers) that are interested in providing year-round (2025-2026) Title I Youth Services, as authorized under the Workforce Innovation and Opportunity Act (WIOA) of 2014. The purpose of this Program is to serve economically disadvantaged youth, 14 to 21 years of age enrolled in school youth, and 16 to 24 years of age out of school youth.


The selection process will be through an evaluation system, in a competitive process, taking into consideration criteria established in WIOA, and funds availability. The proposals will be subject to change consistent with the WIOA and required by the ALDL. The proponent must ensure that it is an accredited entity to guarantee the granting of an acquired skills credential. Programs funded under this RFP must be prepared to comply with WIOA regulations.

Providers must be available to work **WITH A MINIMUM NUMBER OF PARTICIPANTS**. Guidelines regarding this RFP will be available from the publication of this announcement until **April 7, 2025** between 8:00 AM - 12:00 PM and 1:00 - 3:30 PM, at the following address:
